# What are the new General Data Protection Regulations coming into force in May 2018?

GDPR is the name attributed to the new data protection laws which will be fully implemented by May 2018. GDPR will change the way in which businesses obtain, store, use and delete data and will make designated internal data controllers, board members and directors more accountable for the existing business processes around data protection.

The Information Commissioners Office (ICO) which is the government body behind GDPR have stipulated that companies will be penalised and will have to pay a penalty of up to 4% of global turnover.
