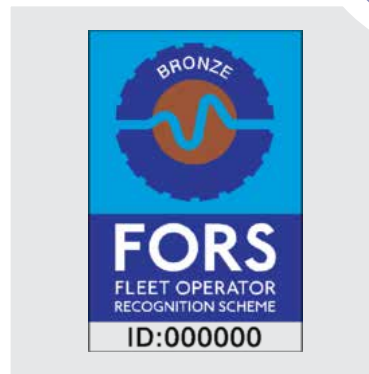

Why do you need to be transport compliant?

It is mandatory for a DVSA (Driver and Vehicle Standards Agency) enforcement team to assess an operator's licence every five years or if their licence is new or they have issued a fixed penalty notice to the operator at the roadside.

If DVSA inspect a site and find the operator is not adhering to their undertakings, DVSA will inform the Traffic Commissioner.

The Traffic Commissioner will likely call the operator to a public inquiry to find out why and has the power to revoke, curtail or suspend the operator's licence.
